**Board Position Application**

The BC Métis Federation board has 4 executive positions and up to 10 at large positions. The following board positions are open for nominations during the 2020 Annual General Meeting;

- President
- Vice President
- Secretary
- Treasurer
- At Large

**Board of Director Membership Criteria**

Only BC Métis Federation members in good standing are eligible for any board position.

1. The membership of the BC Métis Federation consists of the applicants for incorporation of the BC Métis Federation and those Métis who subsequently become members in accordance with the BC Métis Federation bylaws.



2. A person may apply for membership in the BC Métis Federation and acceptance by the BC Métis Federation membership committee shall be registered and become a BC Métis Federation recognized member. All individuals must complete the appropriate BC Métis Federation membership application form.

#### **Election Criteria**

1. Members must be elected to the board at an Annual General Meeting and will hold office for a term that ends after two years and will close at the second Annual General Meeting.
2. The number of terms that a member may hold office as a Director is unlimited.
3. A Member shall be entitled to vote at an Annual General Meeting at which the Board is to be elected if that Member is 18 years of age or older as of the date of the election.
4. A Member who is eighteen (18) years of age or older may be nominated and, if elected, hold office as a Director.
5. Nominations to the Board shall be required to provide proof of BC Métis Federation membership.
6. Any individual applying to be a board member must not have been convicted of an indictable offence.
7. Elections to the BCMF board of directors shall be accompanied with the following documents; the absence of information shall disqualify that candidate:
  - i. A current criminal record check (to be paid for by the candidate) provided by the RCMP and/or Municipal Police; and
  - ii. Proof of BCMF membership
8. Members seeking elected office must have been a resident of British Columbia for at least twelve (12) months prior to the date of the election.
