WHEREAS on Manitoba's Louis Riel Statutory Holiday on February 15, 2016 Prime Minister Justin Trudeau issued a Statement stating in part:

- A) Louis Riel was a champion of minority rights, a founder of Manitoba and a key contributor to Canadian Confederation;**
- B) Louis Riel made important sacrifices to defend the rights, the freedoms and the culture of the Metis People;**
- C) the ideals that Louis Riel fought for- ideals of inclusiveness and equality- are now the very same values on which we base our country's identity**

AND WHEREAS on November 16, 1885 after an unjust, unfair and illegal trial Louis Riel was convicted of High Treason under an inapplicable 534 year old statute of Great Britain, and executed

RESOLVED THAT the BC Metis Federation request the Federal Government of Canada

- i) to reverse Louis Riel's conviction for High Treason and declare without reservation that he is innocent of any crime or wrongdoing including High Treason and**
- ii) issue an apology to the Metis People of Canada for all wrongs inflicted on them, past and present, by the Federal Government of Canada.**
