The BC Metis Federation have provided additional consultation funding support for operational needs of our Metis community as needed on key issues of economic development negotiations, consultation and regulatory oversight, and other operational needs through President Keith Henry and his company KCD Consulting Incorporated since 2011

#### Whereas:

- 1. The Canada Energy Regulator (CER) has several active and pending regulatory review, and funding-related projects for the fiscal years April 1<sup>st</sup>, 2021 March 31<sup>st</sup> 2026: these include but are not limited to:

  - Northriver Midstream
  - Onshore Pipeline Regulations & Filing Manual Review
  - Rules of Principle
  - Pouce Coupe Pipeline Ltd Taylor to Gordondale Project
  - West Coast Energy Inc. sunrise Expansion Project
- 2. The Province of British Columbia has proposed new Metis and Child legislation in 2025

- Engagement with CER, Crown Consolation Coordinators, and relevant Indigenous, governmental and stakeholder groups.
- Acceptance and administration of any CER grants, contributions, or participant funding related to these projects.



Therefore, be it further resolved that the Board further delegates authority to KCD Consulting Incorporated to manage, negotiate, and finalize all matters arising from these projects-including any modifications, expansions (such as future-regulated projects), or related initiatives. Therefore, the board request quarterly updates and reporting on each active project including the status of regulatory requirements, and environmental/Metis engagement plans.
